Dear Ms. Bose:

We are in receipt of the January 25, 2011, letter from Jeff Wright at the Federal Energy Regulatory Commission ("Commission" or "FERC"), Office of Energy Projects. Provided herein is a project status update as requested for the Palomar Gas Transmission, LLC ("Palomar") project.

On February 3, 2011, a joint workshop with Commissioners from the Oregon Public Utility Commission and from the Washington Utility and Transportation Commission was held in Portland, Oregon, at the Port of Portland offices. The workshop discussed regional supply and demand issues associated with the integration of renewable energy, existing natural gas pipeline infrastructure in the region, and the need for additional infrastructure. Numerous regional stakeholders in the Northwest energy industry participated in the workshop. A copy of the workshop agenda is attached. The workshop provided an opportunity for representatives from Palomar and the Williams Companies to explain how Palomar, in conjunction with an expansion of the Williams Northwest Pipeline, will help to provide a regional solution to improve the natural gas pipeline infrastructure in the Northwest. The workshop provided a beneficial exchange of information that will help the state Commissioners and the other stakeholders understand the regional energy landscape as decisions related to new infrastructure projects are made in the future.

Palomar continues to work with customers regarding their needs, and we anticipate that we will hold an open season this spring. Following the open season, we anticipate negotiating agreements with interested customers and determining the revised configuration of the project as well as the required in-service date for Palomar. We hope to have that effort completed in the summer or fall of 2011. Following that, an amended Certificate Application would be filed with the Commission.
